# How do we collect your data?

You directly provide Energy8 BV with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our platform or via email.
- Use or view our website via your browser's cookies.



# How will we use your data?

Energy8 BV collects your data so that we can:

Process your order, manage your account.

Email you with special offers on other products and services we think you might like.

Energy8 BV will NOT share your data with our partner companies.

When Energy8 BV processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

### How do we store your data?

Energy8 BV securely stores your data at data servers in France. Energy8 BV will keep your survey data for 12 months. Once this time period has expired, we will delete your data by asking you permission to delete your survey data.

# Marketing

Energy8 BV would like to send you information about products and services of ours that we think you might like. If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Energy8 BV from contacting you for marketing purposes. If you no longer wish to be contacted for marketing purposes, please contact us on the website.

### What are your data protection rights?

Energy8 BV would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

<u>The right to access</u> - You have the right to request Energy8 BV for copies of your personal data. We may charge you a small fee for this service.

<u>The right to rectification</u> - You have the right to request that Energy8 BV correct any information you believe is inaccurate. You also have the right to request Energy8 BV to complete information you believe is incomplete.



<u>The right to erasure</u> - You have the right to request that Energy8 BV erase your personal data, under certain conditions.

<u>The right to restrict processing</u> - You have the right to request that Energy8 BV restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Energy8 BV's processing of your personal data, under certain conditions.

<u>The right to data portability</u> - You have the right to request that Energy8 BV transfer the data that we have collected to another organization, or directly to you, under certain conditions.

If you make a request, we have one month to respond to you. If you would like to exercise any of these rights, please contact us on the website.

#### What are cookies?

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information trom you automatically through cookies or similar technology.

<u>Advertising</u> - Energy8 BV uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address.
